TERMS AND CONDITIONS****1. REGISTRATION AND PAYMENT**

Submission of a registration is regarded as a firm booking and acceptance of these terms and conditions. However, the registration will not be confirmed until full payment has been received.

**2. FEE STRUCTURE**

- 2.1. To qualify for the member registration fee, your InterPore membership must be current for 2025.
- 2.2. All non-member fees include InterPore membership for 2025.
- 2.3 To qualify for the reduced student registration fee:
  - Students must be enrolled in a full-time study program at a recognized university or institute.
  - A student ID card and/or official proof of enrollment must be provided during registration.
- 2.4. The fee for state and federal agencies, research laboratories, and non-profit organizations is the same as for academia.

**3. CANCELLATION**
